## **Review and Consider Capital Requests for FY24 Annual Town Meeting**

<u>Clean Water Facility- Rough Terrain Vehicle</u> No comments from CIC

Clean Water Facility- Septage Receiving Station Upgrade

The CIC raised a few questions for the plant superintendent. 1) Would the plant receive more septage as result of the upgrade? 2) Will the project be engineered 3) Does this account for site work, electrical? What contingency is being carried? WR to follow up with Chelsey Little.

<u>Public Works – Discretionary fund for large repairs and equipment</u> Current balance is \$82,000. DPW is planning a purchase of replacement paver box by March 1. That will cost about \$53,000.

<u>Public Works- 11<sup>th</sup> St Bridge Rehabilitation Engineering</u> Removed from consideration by WR. Initial engineering assessment is underway.

Public Works - Town Hall Carpeting Replacement

WR shared a recently received prevailing wage quote (\$10,300). CIC wants to incorporate a specification for low VOC adhesives and floor carpet. The CIC will keep the existing budget and ask WR to coordinate with DPW on the specification.

Parks and Recreation- Montague Center Park Improvements CIC would like to see a refined scope for the MC park improvements.

Parks and Recreation- Unity Skatepark Lighting Project

Was the cost of new electrical service incorporated into the skatepark lighting? Will the power and conduit be underground. Will site work be required for that? WR to follow up with Parks Director Jon Dobosz

Economic Development and Industrial Corporation- Demolish 38 Ave A No comments from CIC

<u>Non-capital requests</u> WR to firm up 2 school requests with school facilities director Heath Cummings

## Six Year Capital Plan: Data gaps, scope and timeline

The CIC's goal is to have a preliminary overview of the capital plan for May Annual Town Meeting and draft by September 2023.

WR has assembles all current studies and data sources.

WR has noted data gaps: facility audits for Town Hall, Council on Aging, Police, Colle, and Shea. WR is trying to PCA 360 onboard to conduct the assessments. They have not been responsive so far.

The scope will include facilities, vehicles, and infrastructure. DOT Bridge projects and other special projects will be included in the plan in narrative form.
