 - Topics not anticipated within 48 hour posting requirement
 - Agent reports that Firstlight has filed its license application with FERC. It is currently being reviewed by town staff and partner agencies. 3 river access points are proposed to receive improvements.
 - Landowner at 414 Greenfield Road (Ron Rodden) is seeking a water meter to his parcel's frontage on Meadow Road (opposite the Sawmill River). The lot is not buildable. Agent informed him that underground water utility work does have some limited exemptions if it stays within existing road and driveways. Owner was advised to file for any additional work beyond the narrow exemption.
