 - Would still have to pay him 6 months as that is in his contract
 - Dodge has asked to get the years of service higher; to next birthday
 - He's asked to be on paid administrative leave and would have no authority as Chief; we could search for a full-time replacement
 - This would allow the Police Department to move forward.
- The Town's first offer was to pay him through the end of his contract in November 2018; Dodge countered with 2 years; which the Selectboard is against.
- There is the possibility Dodge may be getting a job elsewhere and they have asked the Board to delay their decision for another week before taking action.

- The Board is willing to put off a decision for another week but at some point this needs to be put behind us even if that means we need to make a difficult decision and move forward so there is closure.
