#### **Presentation on the Affordable Assessment**

Jen Audley provided background for the presentation:

In 2010, leaders from Gill, Montague, and Gill-Montague Regional School District collaborated to craft the "Compact for Funding Education," an agreement to approach the allocation of local funds to our regional school district in a new way. Representatives from the MA Department of Elementary and Secondary Education and our state legislators at the time supported this joint agreement. As we approach the 10-year mark on implementing our "Affordable Assessment" approach, we invited Mike Naughton to reprise and update a presentation he created for the civic leaders group in October 2017 so we could have an opportunity to reflect on how it has worked and what has gone differently than we anticipated.

Mike Naughton is a long-time Finance Committee member who stepped down from the committee at the end of FY19. He served on the oversight group that initiated the process that led to the Compact and on the technical panel that developed it. The other members of the technical panel were Jeff Singleton and Tupper Brown.

Mike Naughton reviewed the draft document he'd prepared for this meeting, called "The 'Affordable Assessment;" A History and Update," which includes 5 pages of narrative, a copy of "Table B," a companion document to the Compact which contains revenue and budget projections for FY10-FY15, a table of updated figure for FY11-FY20 and several graphs showing actual v projected figures and enrollment trends over the past decade. All of these documents, as well as the Compact itself, and an updated version of "The 'Affordable

Jeff Singleton offered some observations and left the meeting for another commitment. Jen Audley read aloud this comment from Tupper Brown:

"In my view the most important thing about what we achieved ten years ago is the political settlement represented by the Compact itself. The relationship between the School Committee (and District) and the towns changed literally overnight from adversarial to cooperative, and amazingly it has stayed that way ever since. In this context the institution of the affordable assessment calculation I've always considered a relatively minor detail. The really important thing was getting everyone, including DESE and the legislators, to sign on to a joint plan as evidenced in an actual written agreement - called the Compact - with the intention of making it work."

In the discussion that followed, numerous people described the positive effect the Affordable Assessment approach has had on the annual budget process for the towns and the district, as "more collaborative," "trusting," "increased stability," and "reducing uncertainty." No votes were taken, but there was a clear consensus in the room for continuing the agreements described in the Compact.

#### Finance Committee Minutes of September 11, 2019

The committee voted unanimously to approve the 9/11/19 minutes (prepared by Mr. Hanold), with that addition.
