  - The Chair announced that the meeting is being recorded by the Town of Montague via Zoom and asked if anyone else was recording the meeting. No one else was recording the meeting. #### #2 Town Administrator's Updates

- Updates on Financial Policies and Financial Planning Projects. Steve Ellis and Rob Addelson will meet Thursday September 17 to review five draft policies and Steve Ellis, Jen Audley, and Josh lively will meet to discuss Capital Planning on Monday September 21. A first review of the five draft policies by the Finance Committee is anticipated at their September 30<sup>th</sup> meeting.
- The Capital Improvements Committee will meet on September 23<sup>rd</sup>, but anticipates continuing to expect submissions by early November.
- The anticipated CARES funding of \$750,000 for COVID-19 expenses will continue to be clarified. There will be more information on this at the September 21<sup>st</sup> Selectboard meeting.

### #3 FY21 Special Town Meeting Warrant October 13, 2020

Town Administrator Steve Ellis announced a final warrant approval deadline of September 28, with mailing on September 29. Ms. Audley suggested that Town Meeting members be warned to "save the date" sooner. Mr. Ellis presented, for discussion and approval by the Selectboard, the draft warrant for the meeting, which is scheduled for 6:30 PM at the new DPW Garage.

\*Articles 10 and 11: Ms. Bourbeau explained these articles as more efficient for setup and more consistent with other elections; she anticipates final action by the Massachusetts Legislature.

- Decreasing the Town Counsel budget by \$10,000
- Decreasing the Public Building Utilities budget by \$35,000
- Decreasing the Veterans Services budget by \$10,000
- Decreasing the Employee Benefits budget for health insurance by \$60,000

This article will reduce the use of taxation by \$109,000

Mr. Kuklewicz observed that in the future they will automatically be directed to the destination funds. The new breakdown would be:

Article 7A:

- 1. \$73,652 from Free Cash to the Town Capital Stabilization Fund, representing the FY20 revenue from Cannabis Sales Tax
- 2. \$35,791 from Free Cash to the Cannabis Impact Fee Stabilization Fund, representing the FY20 revenue from Cannabis Impact Fee revenue.

1. \$61,507 from Taxation to the Town General Town Stabilization Fund

**SECTION 1.** Section 1 of Chapter 9 of the Acts of 1974 is hereby amended by striking the word "Monday" in the first sentence and replacing it with the word "Tuesday".

**SECTION 2.** This act shall take effect upon passage.

Chapter 9, Acts of 1974, "An act relative to the dates of the Annual Town Election and Town Meeting held in the Town of Montague". Be it enacted as follows: Notwithstanding the provisions of any general or special law or by-law of the Town of Montague to the contrary, said Town shall hold the Annual Town Meeting for the election of Town officers and the determination of such matters as by law or vote of the Town are required to be elected or determined by official ballot on the third Monday in May of each year. All other business shall be considered at a meeting to be held on the first Saturday of May of each year. Separate warrants may be posted for said election and business meetings.

And replace it with the following:

# ANNUAL AND SPECIAL MEETINGS

<u>Section 2</u>: Notwithstanding the provisions of any general or special law or by-law of the Town of Montague to the contrary, said Town shall hold the Annual Town Meeting for the election of Town officers and the determination of such matters as by law or vote of the Town are required to be elected or determined by official ballot on the third Tuesday in May of each year. All other business shall be considered at a meeting to be held on the first Saturday of May of each year. Separate warrants may be posted for said election and business meetings.
