#2 Approve Meeting Minutes

#3 Prepare for FY21 Tax Classification Hearing

- Ms. Tonelli described the process used to assess market values. The State
 prescribes that valuations be equitable across each property type and recognize
 sale experience. Montague uses a CAMA (Computer Assisted Mass Appraisal)
 software package to collect the data used.
- The valuations are adjusted annually, based on twelve defined neighborhoods. It lags current data by about a year.
- Every town goes through revaluation and certification by the Massachusetts Department of Revenue every five years, including examination of procedures and office records.
- Actual visits to properties occur every ten years. A taxpayer can protest the
 assessment at any year by assuming the burden of proof that the assessor's
 data is incorrect.
- The sequence of events leading up to the Tax Classification Hearing begins with selected site visits in the winter and spring followed by data analysis in the

summer and an estimate of New Growth in the fall. The Tax Classification Hearing is generally held at a Selectboard meeting in late October and covers three districts (two fire districts and one lighting district) and the Town. The approved tax rates form the basis of tax bills mailed in early December by the Treasurer.

#4 Town Accountant and Town Administrator Updates

- Carolyn Olsen: The department spending report, as of the end of the first quarter, shows no surprises or concerns.
- Steve Ellis: No news, beyond an update on collection rates. 90% of property taxes and 99% of personal property are paid, to date, quite similar to recent years, due in part to good communication and attention from the Treasury staff.

#5 Prepare for Fall Special Town Meeting (October 13, 2020)

- The Warrant, Motions and Background Information were sent out last week by Wendy Bogusz.
- Jen Audley assigned responsibility for initial explanation of the finance articles on the Warrant:
 - Art. 1 Changes to FY21 budget. Ellis & Olsen will begin, and Finance Committee will endorse the article prior to Town Meeting discussion.
 - Art. 7 Financial Policies. Audley will describe the five funds, and delegate follow-up questions to Committee members.
 - Art. 8 Cannabis. Hanold will speak.
 - o Art. 9 Reserve Fund. Garrison will speak.

#6 Discuss Draft Financial Management Policies

 Some comments were received during the week. Mr. Ellis is also working to harmonize our human resources policies. That effort will involve bargaining-unit discussion, and was suspended in recent months as COVID-19 demands have arisen. Montague has few people in most departments, and relies on board/committee support to ease management succession.
