# Update from Chelsey Little, Supt. Clean Water Facility re: Hydroelectric Study Grant.

META grant application for \$6000 for feasibility study on small hydroelectric turbine, awarded in late Feb. Working with J. K. Muir for study. Will focus on two potential locations, select best one. Also will identify options for equipment, costs. Completed study will go into Gap grant application to DEP for cost of equipment. Clean Water Facility (CWF) would be able to do installation. Chelsea expects study will be finished next January or February.

# Community Planning For Solar with U. Mass. Clean Energy Ext. 4:50 PM

Report on and response to Solar Forums

Sally reported that the Department Head Solar meeting took place May 15, with Maureen Pollock, Steve Ellis, Brian Camden from Airport, all 3 Extension faculty members, Sally, and Tim attending. Slides are available on our web page under Reports. Good discussion about grid capacity. Zara Dowling has talked with Walter Ramsey about net metering; for example prospective D.P.W. solar could net meter to schools or other entities so contract with Kearsarge would still be observed. Sub station development elsewhere such as one planned in Whately could increase Montague capacity if on the same line.

Ariel asked at the May 22 Solar Forum for residences and businesses if the Clean Energy Extension's projections for increased demand for electricity include potential for energy efficiency. Answer was vague. Possibility of community solar discussed.

Sally also reported that state has received big grant for Solar For All, aimed at solar for low income residences.

Sally looked into status of Act to Expand Modern Grid, sitting at House Ways and Means Committee. Has just asked Natalie Blais where that stands, and if her read of the bill is correct. Also asked if letters of support would help.
