Tim and Steve,

We (Nova) reached out to 2 PACE lenders. We explained our plan and both lenders were not that interested in providing funding because of our low (\$125000) amount. So while the state did not include a minimum loan amount in their legislation, the private lenders definitely have one in their minds.

The other downside to the loan is that it comes with relatively high closing costs, estimated at about \$18k which can be rolled into the loan,

but still expensive. Additionally the administration fees...which were not fully disclosed until we got the approval, which I think they said was about \$1000 a year.

We thought it may still be worth the added costs because we had no other options but the lenders didn't seem interested.

I reached out to Julie Cowan at MassDev about our experience and she indicated that she would get in touch with them and see what could be done. I will touch base with her this week to see if she was able to twist some arms.
