# **Montague Energy Committee**

## Approved minutes from January 25, 2022

#### State-level energy-related policies & legislation

- Municipal sign-on letter for Green Future Act: Selectboard had questions that committee members could not answer, they did not yet approve the letter. Rich Kuklewicz did not expect we'd get much money from carbon pricing initiative. 40% of Montague is in moderate or low income, these people would see money back from that program.60% or above would see 20 dollar increase in their fossil fuel bills. Originally needed to be voted out "favorably" to progress, this bill got an extension until May 2. (passing seems not likely even though there is public support) This will be brought to the next selectboard meeting. Matt Lord may get behind it with enough information and convince other selectboard members. Matt Lord is willing to take a deep dive into the topic, but was looking at senator Barret's bill which was not progressive. The new bill, based on the Benson bill, is more progressive.
- Letter from Sally on 100% Clean Act. She suggests we should focus on the Green Futures bill, rather than diluting our efforts.
- Sally also notes anti biomass bill was voted out of TUE (telephone and utility committee) and we need to have it not have the loophole allowing existing biomass plants to be deserving of credits.
- Stretch codes were discussed. The existing one, to be updated, and the net zero stretch code which was vetoed by Baker. That could could be opted into. Chris suggests we should support this.

## Update on gas industry seeking to prolong the use of methane fuel.

• Ariel notes there is a new push by natural gas suppliers to portray their gas as green. The pipeline awareness newsletter has the most succinct summary. Gas companies are intending to preserve existing pipelines because they are going

to supply hydrogen into the natural gas stream. Ariel suggests we should look at her info and take this up at our next meeting.

## **Energy-related Facility Updates:**

- Outdoor lighting upgrades to LED
  - Tim says we could use green communities grant funding to pay for the purchase of the eversource lights and upgrade them to led's. George Woodbury has had them shut off a number of Montague center lights. Some question if Eversource is offering lamps that are too bright... Chris would suggest against this... Tim also notes that "dark skies compliant" lighting has been installed at the Discovery Center and Second Street parking area.

PV and battery storae on Safety Complex
PV and battery storage at DPW
Vehicle chargers at town hall,
Geothermal and distric heating.
Chris suggests electric school buses
Reuse of the Farren... nothing in sight
Staff funding at FRCOG to help coordinate sustainability projects

## Examine the role of the Committee in educating the public:

- Bob suggests Mass Save should do their own outreach.
- Chris notes that the COG had hired a full time person, they knocked on each door twice, and increased participation by 6%. This was considered "massively effective".
- Sally and Chris discuss: you can give them info and give them money but its not enough.

- Sally notes there may be large incentives for air source heat pump, after implementing Mass Save efficiency measures, \$15k total, 1250/ton for the minisplits,
- Sally is considering a letter to the Montague Reporter,
- Chris is organizing a meeting with National Grid and Eversource around 4:15 on Wednesday, on their energy opportunities.
- Bob notes Leverett has suggested "no idling" signs at their library and other locations.
