ANR #2010-01 by HBM Properties: Property located on West Chestnut Hill Road, Montague, MA 01351 (Off North Leverett Road), Assessor's Map 52 Lot 080.

Carolyn Manley (L & F Construction): This property was originally a part of a 99 acre piece of property, a part of the parcel is located in Leverett, MA. An abutter would like to have part of this field to complete his parcel of land in Leverett, for esthetic reasons, he would like to purchase this small piece of property located in Montague. I have already been to the Town of Leverett Planning Board and they signed the ANR for their piece of the parcel, which is the larger portion of the field in the parcel. I am asking for .14 acre that is in Montague that I am here to request the ANR on. Carolyn Manley: It creates a small new lot in Montague, which is why Planning Board must hear this request. Out of 99 acres it creates a lot of .14 acres. The abutter is requesting this strictly for esthetic reasons.
