Approval of Minutes:

<u>Motion</u> by Ron Sicard to approve the August 27, 2019 Minutes as presented. Seconded by George Cook. **Motion passes.**

ANR #2019-08 filed by Michael Naughton of 11 South Lyman Street, Millers Falls, MA requesting endorsement of a plan is believed not to require subdivision approval. The property is located at 27 Massasoit Street, Lake Pleasant, MA 01347 and is identified as Assessors Map 36 Lot 64.

Guests: Michael Naughton – owner and David Jensen - abutter

Michael Naughton: The plan is to divide it into two lots because the current abutters (David Jensen and Theresa Turner) are interested in each buying a piece. In wanting to create the lots some thought was given to how to best divide and it was decided to do it so that each abutters gets an equal share with David Jensen's piece getting a little bit more road frontage so that Michael Naughton can be fair and charge them the exact same price for the property.

Planner: The parcel 8,400 square foot parcel it pre-existing non-cofnforming. It will be subdivised and combined with two abutting non-conforming residiential lots- making them "more conforming". Each lot is left with adequate frontage.

George Cooke previously noted that the requisite endorsement notes required in the Subdivision regulations had not been put on the submitted plan by the surveyor – this has now been done.

Planner: This is revising an overlook in the 2018 ANR plan that was improved. This involves a transformer pad that is integral to Makin's parcel was inadvertently "given away" to the abutter I nthe plan, but that was not the intent of the sale.
