Proposed Regulations: In a previous meeting, Ms. Olsen was asked to draft supplemental regulations to require all new retirees to have direct deposits, and to require that board members meet certain obligations in order to receive their stipends. The proposed regulations are:

Miscellaneous #7

All retirees who retire on or after July 1, 2013 shall be required to receive their total benefit as a direct deposit unless they can show this would cause a hardship Miscellaneous #6 A board member who misses more than 2 board meetings in a calendar year for other than personal or family illness shall not be paid for the months when the additional meetings were missed. If payment for that month has already been processed, then the subsequent payment shall be forfeited.

A board member who has not received 3 hours of credited training in a calendar year shall forfeit their stipend until such training requirement is met, with the stipend to resume for the month following completion of the training requirement.

A board member who has not submitted his or her Statement of Financial Interest by the due date shall forfeit their stipend from the due date until the month following the submission.
