**Membership Discussion & Clarification:** Board to discuss and clarify membership requirements for temporary workers, especially high school and college students.

## Discussion:

The Board discussed a current Franklin County Tech School student who has worked at the Airport since 2021, with his hours increasing each year. He will now be working 20 hours per week regularly, so he will be enrolled in the retirement system effective immediately. There are other new and current part-time and seasonal employees for whom it is hard to administer the current Board regulations as there is not sufficient notice to the Board and Town Accountant of changes in hours.

The Board discussed the pros and cons of membership for the employee, the administrative issues, and the likelihood of an employee getting a refund of retirement deductions vs OBRA deductions.

The Board also discussed our Eligibility Regulation #1A which defines *temporary employees* as *those expected to work fewer than 3 months*. Since some students have a summer break longer than 3 months, the Board discussed changing the regulation to *those expected to work fewer than 4 months*.

On a motion by Steven Ellis, seconded by Carolyn Olsen, the Board voted to change Board Regulation #1A to the following:

Temporary Employees are defined as those employees expected to work for fewer than 4 months. If an employee is hired to work for fewer than 4 months, but actually works 4 months or longer, and works a regular schedule of at least 20 hours per week, they shall become a member of the system in the Unit where they have worked for at least 4 months.
