Dear Honorable Selectboard,

On Wednesday June 18, 2025, the Montague Board of Health voted to recommend that the Selectboard petition for Montague join the Pioneer Valley Mosquito Control District. This recommendation comes after many different discussions that occurred at public meetings in 2024 and 2025.

The Montague Board of Heath recommends joining this Mosquito Control District (MCD) based on the importance of surveillance in preventing arbovirus transmission in our community.

Membership for each fiscal year would cost the Town approximately \$5,250 and would be funded by the Mosquito Control account that was funded through appropriation at the 2021 annual Town meeting. After the initial appropriation, the Montague Board of Health intends on incorporating the expense into our regular department budget requests.
