SECTION 9

SEVEN YEAR ACTION PLAN

The Seven-Year Action Plan addresses the objectives of the Open Space and Recreation Plan and identifies actions to meet these objectives. While the Open Space and Recreation Planning Committee believe that all of the objectives are important and should be pursued, it is also necessary to establish priorities for the next seven years. At the public forum held on September 23, 2010, members of the Committee and the public identified fourteen objectives for priority implementation during the next seven years. These objectives are represented graphically on the Seven Year Action Plan Map, and are included in Table 9-1 below. The fourteen priority objectives are:

- A.1. Encourage permanent protection of large blocks of contiguous forest and establishment of corridors between existing protected forest parcels.
- A.2. Encourage permanent protection of land along the banks of the Connecticut, Sawmill, and Millers Rivers and support ecological restoration efforts in these watersheds.
- A.10. Promote cleanup and redevelopment of abandoned and underutilized industrial and commercial properties.
- B.7. Develop water conservation strategies.
- C.5. Promote conservation of valuable agricultural soils and permanent protection of farmland through the APR program, consistent with the plans and desires of landowners.
- D.3. Explore the feasibility of developing a park in Montague City.
- F.2. Support the formation of a volunteer "Friends of the Montague Plains" group to assist in stewardship and management of the Plains.
- A.4. Revise Montague Zoning Bylaws to direct development to appropriate areas without devaluing the land and, where possible, to allow clustering of homes on smaller lots to protect open space when land is developed.
- A.7. Consider adoption of a local wetland protection bylaw.
- A.8. Investigate funding mechanisms for Town acquisition of open space, including adoption of the Community Preservation Act by Town Meeting with at least a 1% property tax surcharge.
- C.3. Develop a Right to Farm Bylaw to protect farmers from complaints about odors and sounds due to normal farming activities.
- D.2. Ensure affordability and accessibility of recreational areas and programs to all Montague residents, including development of at least one ADA-accessible facility.
- E.2. Promote environmental education in Montague schools, with a special focus on local resources.
- F.1. Partner with the state Department of Fish and Game to improve management of the Plains.

While these objectives have been identified as priorities for the next seven years, all goals and corresponding objectives from this plan are listed in the far left column of the foldout Table 9-1 in the same order as they appear in Section 8. They are followed in the same row by recommended actions, the board or group responsible for implementation, start dates, and potential funding sources. By implementing the recommended actions, each of the objectives will begin to be realized.

The Open Space and Recreation Planning Committee recommend the creation of three new bodies to facilitate implementation of the Plan: an Open Space Committee, an Agricultural Commission and a non-profit, volunteer "Friends of the Montague Plains" organization. Successful implementation will also require the participation of existing Town boards, committees and staff, including but not limited to the Board of Selectmen, Planning Board, Conservation Commission, Parks & Recreation Commission, Board of Health, Fire and Water Districts, Town Planner, Parks & Recreation Director, Health Director and others.

Accomplishing the actions identified in this section will require time and commitment from dedicated volunteers. Where money is required, it may be sought from state and federal governmental agencies, private non-profit conservation agencies, foundations, and individual donations in addition to municipal funds. A broad base of community support for the Open Space and Recreation Plan should facilitate fundraising to achieve its goals and objectives.
