Review and discussion of FirstLight Settlement Terms

Ellis: Beginning in FY14 FirstLight gave notice that it was not in agreement with the valuation of its assets, specifically related to two pieces of real estate and their personal property. Montague's value (90%) were valued at \$114 million. That carried through for FY14, FY15, and FY16. In FY17, we had hired a qualified appraiser who assessed the property at \$135 million. Any disputed value is subject to an 8% interest rate. The longer this continues, the more jeopardy it presents to the Town. We have been putting an extra \$275,000 beyond the normal amount into an Assessors Overlay Account. FirstLight agrees to withdraw and not pursue any abatements relative to FY14, FY15, or FY16. We struck a deal and went from \$135 million to \$125 million. Through the agreement the Town was able to successfully resolve and give nothing back on the first three years; we will not in any of our abatements be subject to the 8% interest for FY17, FY18, or FY19; and we have a tax agreement that would hold the \$125 million value for the next two years subject to Town Meeting approval.
