# • DPW Project Update

Ellis: Site work is nearly complete. The land was found to be an amenable surface for the contractors to work with. The steel building is scheduled to be delivered in late November. The expected date of completion is in the first week of June 2020. We would expect to come in over \$1 million under budget should we not encounter any issues. We are going to ask our the OPM to get us some cost estimates for a refueling station on the property which will be considered by the building committee and could potentially be brought to the Selectboard for consideration.

# • Colle Opera

We are at the point of substantial completion of the Colle Opera project. Kuklewicz expressed his wish to not let the project be considered complete until the protection that was put on the electrical wires have been removed. Mr. Ellis advised that Eversource has been contacted.

### • Shea Theater Roof

The new Carlisle roof membrane is installed and roof drains returned to working order. The metal edging along the parapet wall still needs to be finished. We will be asking Northeast Roof Consultants and Chris Sawyer-Laucanno to make a final assessment of the roof and schedule warranty review by the manufacturer.

### • Town Hall Annex Roof

The old decking is in great condition overall. The crickets have had to be rebuilt, some plywood sheathing has needed to be replaced and extensive work was done on the roof drains. The equipment room roof will be worked on once the main roof is complete. We expect to be within budget at this time.
