- Update on Millers Falls Road Embankment Repair
  - On Thursday 1,362 tons of material was brought in, and on Friday 1,568 tons was brought in.
  - o On Tuesday, another 1,300 tons will be brought in.
  - On Wednesday, the equipment operator will start stabilizing the base so that pipe can be put together and buried.

#### • Engineering Services Update

- The update is still in the works.
- Ellis shares that he feels reassured that the approach we are taking is a reasonable and appropriate remedy.

## **Review of any Updated State Guidance or Orders**

- The total number of cases in Montague remains at 29.
- 2,496 COVID tests have been administered to Montague residents.
- With regard to the travel order, New Mexico has been added to the lower-risk states; but Delaware, Pennsylvania, and West Virginia have been removed from the list.
- There are still some clusters of cases in the eastern part of the state.

## Chelsey Little, WPCF Superintendent FY2021 Sewer Rate Hearing

- Little reviews the Sewer Rate Explanation 2020 spreadsheet. She recommends a 3% increase for 2021.
- Boutwell comments on how residents don't like to see large increases.
- The press to get the water out from the paper byproducts will probably consume about half of the retained earnings that presently exist.
- Ellis would like the Board to consider how we should go about establishing enough of an ongoing retained earnings pool so that everything that comes does not have to go directly onto the rate. Either the 2% or 3% scenario would give an appropriate cushion.
- Little would like to consistently keep the increases small each year.
- Kuklewicz would prefer the 2% as folks will be hit with a good increase because of the DPW facility. In addition, we are facing unknowns with regard to state funding.
- John Hanold feels that "cutting this too close to the bone is unrealistic." He is in favor of 3%.
- Boutwell makes the motion to authorize a 2% increase in the sewer rates. Seconded by Kuklewicz, unanimously approved. Boutwell Aye, Kuklewicz Aye

## Chelsey Little, WPCF Superintendent Update on Millers Falls I/I

- Bob Trombley and Little met with Peter Sanders from Erving and had discussed some of the ways to tackle finding out where all the excessive I&I is coming from. There will eventually be a public outreach session.
- CATV will camera the lines and check on all the repairs that were done last year.

- Applicants looking to participate in the RiverCulture Mural Program are required to give more documentation and to present their proposal to the RiverCulture Steering Committee.
- Ramsey states that this policy was shared with local landlords and received nothing but positive feedback.
