- There are three phases slated for vaccine availability. Wasiuk summarizes who the first individuals to receive the vaccination are. At present it looks as though the vaccine will not be available to the general public until approximately April 2021.
- One of these locations is a regionalized clinic at UMass.

Update on Montague COVID case counts and other summary data

Active cases from Dec 5 through 19 equals 37 cases; Cumulative cases from October 1 through December 19 equals 95 cases; the total positive cases since the beginning of the pandemic from March 1 to December 19 is 124.

Town Administrator's Report

Discuss CodeRED add-on feature, Foreign Language Message Translation

- o Ellis states that for a modest sum, we could potentially add the ability to share messages in multiple languages.
- o Bogusz states that for \$250 per year, we could have a service that enables us to record a message in Spanish plus two other languages.
- The Board approves the service Bogusz mentions.

Discuss IT Coordinator Position & Update on FY22 budget

- Ellis reports that our long-term IT consultant will be leaving his position, which could have impacts on our FY21 operations. Our IT consultant is willing to remain a resource via remote. The Town needs to decide whether we should budget for external resources or whether we should bring someone in and have a full-time IT coordinator.
- o In response to a question by Nelson, Ellis states that currently Lieutenant Bonnet takes care of the IT needs for the Police Department.
- Nelson states that as technology is at the forefront of everything we do, to have any interruption would be detrimental to the community.
- o Kuklewicz believes that finding somebody with the depth and skill set as our current IT consultant might be a difficult and expensive hire. He suggests either looking at a contracted services or a hybrid approach. The hybrid approach would consist of hiring someone with the skills to handle networking and hardware issues, then having a second-tier contracted services that can handle the more high-tech issues.
- In response to a suggestion by Nelson regarding a shared service with a neighboring community, Ellis states
 that the FRCOG has in the past considered the possibility of trying to create some type of regional IT solution.

- Ellis feels that the biggest thing we have lacked at times is project management capacity as relates to IT.
