#### S. Ellis:

- Kearsarge has been waiting on their survey firm to make progress on a particular right-of-way that allows them to maintain and access elements of their existing 2 solar arrays that are part of Phase 1 as well as the burn dump solar array which we refer to as Phase II.
- Essentially the burn dump encompasses part of the area that was formally the transit area used by our DPW to move between their facilities through the back roads to the transfer station
- What is presented to us are two modest amendments to our lease agreements for Phase I and II, as well as public notices Kearsarge is required to file and a survey plan.
- The documents are currently being reviewed by our Counsel and are considered as administrative
  and procedural and not consequential to the fundamentals of the leases. They simply have to be
  brought into alignment so the company a) has the access it needs to do the work and b) provide a
  complete set of documents to its funders for the newest project

#### E. Tatelbaum:

- Last fall additional waste was identified which slowed down the project. The solar proceeded to the point it could.
- With GZA the Town's consultant we went back to DEP to get updated design approved to cover additional waste identified during construction.
- Design was submitted end of last year and was approved early March.
- Once approved Bates, contractor for capping got back in the field about 2 weeks ago as they waited for thaw as they needed conditions for the soil because they needed conditions ready for grading
- Bates is in the field finishing the Northern cap so the solar can finish first, we expect to be done in July, pending Eversource
- Final cap work to the South will be finished in the Summer
- Ramsey states he review the survey plan and it is consistent with the Planning Board approvals and all the local approvals.

# Topics not anticipated in 48 hour posting Walter Ramsey, Town Planner

Two Friday's ago, Senator Comerford's office submitted a letter to Gov. Baker that lists projects within her district that are to be included in the FY2022 Capital Plan and this includes a request from Montague. Specifically for the demolition and rehabilitation of the Strathmore Mill site. She went through and found existing bonds that had already been approved. In this case the Strathmore Mill complex rehab was put into Chapter 209, of the Acts of 2018 which earmarked \$5 million for this project. We are now at the point where the Senator and others are advocating for fund to be released as part of the FY22 plan. Senator Comerford requested Towns put in a letter of support to release these funds. I feel delaying this a week would be detrimental but I ask the Board make a simple request to the Governor as these funds are already part of legislation.

- This is for partial demolition and rehabilitation of the mill complex
- The time is right for state investment because of other state and federal investments that are ongoing up and down the canal district.
- This is an opportunity for the state to show its investment in the vision they helped support through that previous abatement grant.
