#### **Review of Montague COVID Case Counts and Trends**

- Case counts between September 5 to 11 equals 8, 2 of whom were fully vaccinated and 6 of whom were not. Four were between the ages of 18-35, 3 were between ages 50-64, and 1 was 81+.
- Case counts between August 29 and September 11 equals 21.
- Ellis states that we did not see a continued escalation; we saw it fall back to the weekly number we've been seeing since the middle of August.

#### Consider any necessary response to recent trends

- Zamojski states the BOH feels that the numbers don't presently warrant a mask mandate.
- Ellis states that the EMT feel that we should not react too late to a crisis. If the number reaches 13, then the EMT would like to implement a mask mandate inside Town buildings.
- Kuklewicz encourages residents to wear masks when in large groups.
