FY2023 Selectboard Personnel Requests Community Information Session

Ellis summarizes the Overview of the Proposal. Topics covered include reasons for increasing Selectboard Office staffing, the current FY22 Budget and Staffing, an Overview of the Town Departmental Structure, the Assistant Town Administer Role, the Functional Roles of the Town Administrator and Assistant Town Administrator, the cost, and the way this would serve the Town's interest.

Discussion:

- In response to a request by Judith Lorei, Ellis shares information regarding staffing consideration for other towns of different sizes.
- In response to a question by Pamela Hanold, Ellis shares how he feels increasing Selectboard Office staffing would benefit other departments. Kuklewicz gives examples of projects that would have run more smoothly had we had somebody who could more actively be involved (i.e., an Assistant Town Administrator).
- Ariel Elan recalls previous projects that would've greatly benefited from having an individual who was more actively involved.
- Mike Naughton expresses his opinion that the Selectboard has so many different responsibilities that increasing its staff would require an "incredibly (unbelievably) flexible professional." He is of the opinion that the responsibilities should be spread out more, especially when the time comes to address turnover (when Ellis and Bogusz are no longer going to be with us).
- In response to Naughton's comments, Lord states that project management/infrastructure development is a different set of skills than "tasks." He feels that Ellis's proposal makes sense as "so much of the capital/infrastructure investment, planning, project management is sort of grant-oriented, and so comes with a government-relations flavor that the Selectboard Office carries." With regard to the overall issue of concentration of duties and how to deal with turnover, there is an explicit orientation on human resources development.
- Lord hopes that as new systems are developed, there is redundancy and ability for multiple people to help things go smoothly.
- Hanold expresses concern about the definition of duties of the new position. He wonders if we will have increased our demands when we have only increased our supply of resources a little bit, which would still leave the staff on the Selectboard overextended.
- Hanold expresses his concern about the classification of the new position as there has not been any specific job description or appeal to a Pay & Class Study that would indicate why a Grade I is the right one.
- Detmold expresses his concern that there seems to be a tendency to consolidate power within the Town Hall to the exclusion of collaborating with the citizens the Town Hall serves.
- Kuklewicz responds to Detmold's comment by stating that we are constantly advertising for open positions of various boards, but getting volunteers from the community has been difficult.

Ellis: Senate 2801 has moved to the House, this is an act relative to equity in the cannabis industry. I think the general consensus is that potentially there are really positive things relative to the social equity component of managing cannabis enterprises and there are a lot of different elements to the legislation. The one the Town had expressed the most concern about related to the potential treatment of host community agreements and the notion that there would be a retroactive look back at all HCA's and potential complications from either undoing existing agreements with uncertainty relative to what that might mean for the revenues that have already been collected or past expenditures. There was some real progress made in terms of community voice making its way into the legislation as it came out of the Senate, and it is my understanding that the House may take up the bill, as it left the Senate. I think we would look at it as substantially advantageous in that regard. This will be something that we continue to watch carefully in the coming months
