- A colleague of Ellis informed him that as of this morning, there are 106 patients with a diagnosis of COVID in the Baystate system, two of whom are critical.
- Hospitalizations continue to rise.

• Execute Trash and Recycling Contract

Boutwell makes the motion to execute the Trash and Recycling Contract, and authorize the Chair to sign it. Seconded by Lord, unanimously approved. Boutwell - Aye, Lord - Aye, Kuklewicz - Aye

Ariel Elan, Montague Energy Committee DPU "Future of Gas" Docket 20-28

- Ariel Elan shares that the Montague Energy Committee voted to submit a public comment to the Massachusetts Department of Public Utilities. She reads aloud a letter of introduction.
- The DPU's deadline is June 22nd.
- Lord states he does not feel that the Montague Energy Committee's position is clear in the letter. Kuklewicz agrees and feels that the letter should end with a restatement of what it is we want.
- The Committee will bring an edited letter to the next meeting.

Town Administrator's Business

• Execute Delegation Agreement for a Sole Assessment Center between Montague Police Dept. and the Mass. Human Resources Division, Requisition #8589

Boutwell makes the motion to execute the Delegation Agreement for a Sole Assessment Center between Montague Police Dept. and the Mass. Human Resources Division, Requisition #8589; and authorize the Chair to sign it. Seconded by Lord, unanimously approved. Boutwell - Aye, Lord - Aye, Kuklewicz - Aye

Congressman McGovern files \$675,000 Federal Earmark Request for Avenue A Streetscape Improvements

- Ellis shares that Congressman McGovern filed \$675,000 Federal Earmark Request for the Avenue A
 Streetscape Improvements. These are focused on the north end of Town from 3rd Street to the bridge. We
 had requested \$975,000.
- We will get a sense whether Earmark survives when a Federal budget is likely passed.
- o Ellis thanks everyone who signed letters of support for us.

• Cannabis Host Community Agreement Legislation Update

- o Ellis reports that the House and the Senate have both passed version of a cannabis reform bill.
- o This legislation indicates that there would be no impact fees after a five-year term.
- Ellis suggests that when we have the bill in its final form the Board consider what the implications of the final product might be for how we conduct our business.
- o In response to a question by Kuklewicz, Ellis states that this will not affect our sales tax revenue.

• FirstLight response to actuator Hydraulic Leak

- O Tighe and Bond prepared an Immediate Response Action Plan on behalf of FirstLight Power regarding a release of hydraulic oil from pistons 7 and 8 of Bascule Gate #4 at the Turners Falls Dam.
- Kuklewicz asks whether FirstLight has considered an improvement that could reduce or eliminate the need for constantly pressurized hydraulic cylinders. Ellis states he will send a note asking that Kuklewicz be connected with their Director of Government Relations.

• Topics not anticipated in the 48 hour posting/Transfer Station closed

The Transfer Station will be closed on Wednesday, May 25th. They are going to begin making improvements to Sandy Lane as part of the FRTA Bus Garage Maintenance Project. They will, however, be open on Saturday from 7:00 AM to 4:00 PM.
