Dear Nancy and Jason Pike:

On Wednesday, August 3, 2022 at 5:00 pm in the Montague Town Hall, located at 1 Avenue A, Turners Falls, MA 01376, the Montague Selectboard will hold a public hearing in accordance with Massachusetts General Laws, Chapter 140, Section 157, to determine whether the dog owned and/or kept by you in the Town of Montague is a Nuisance Dog or Dangerous Dog as those terms are defined in said statute. This hearing is at the request of Calin Giurgiu, Animal Control Officer stating your dog is a public safety concern, is unvaccinated and unlicensed in the Town of Montague.

In accordance with its statutory authority, the Selectboard will conduct a public hearing, which shall include an examination of the complainant under oath, and based on the credible evidence and testimony presented, it may make such findings and order concerning the restraint or disposal of your dog as may be deemed necessary, which may include an order that the dog be euthanized.

You are invited to attend the hearing and at that time you may produce any documentation and/or witnesses. You may be represented by counsel at your own expense if you so choose. You may make an appointment to examine the public records in the Town's file on this matter during regular business hours.

She was knocked to the ground and received some scrapes and cuts. The dog was called back into the house by a female at the residence, however, no one came out to speak to her or acknowledge the incident. On 05/24/0222 at approximately 0919 Detective Moody and I, Officer Pervere, both of the Montague Police Department, responded to the area of 11 meadow road to investigate an animal complaint reported by Megan Seymour. Megan reported to Montague Dispatch that while walking her dog past 11 Meadow road, a loose dog ran from the yard of 11 Meadow Road, knocked her to the ground and the owner of the dog did not come forward to Megan.

Upon arrival I spoke with Nancy Pike of 11 Meadow Road. Nancy stated that the dog that got loose from her as she was trying to tie it to the cable run belongs to her son Jason Pike. Nancy described the dog as a 2 year old 120 pound pitbull mix named "Titan". I asked Nancy if the dog was registered and up to date on shots. Nancy was unable to provide any documentation or tags relating to the dogs registration and shot status. I later checked the Town of Montague Dog registration and did not find a dog registered to anyone at 11 Meadow road. I asked Nancy to advise Jason of the incident and to have Jason call the Montague Police Department when available. I did not receive a call from Jason on the day of the incident.

After speaking with Nancy I spoke with Megan at her residence of 15 Old Northfield Road. Megan stated that while walking her dog in the area of 11 Meadow Road, Titan ran out of the yard and ran "through her" to get to her dog. Megan stated that Titan knocked her to the ground causing abrasions to her arms. Megan stated that Titan did not bite her or her dog and eventually went back to the yard of 11 Meadow Road however, no one from the residence spoke with her regarding the incident. Megan stated that after the incident off duty Montague Center fire fighter Fisk treated her abrasions prior to going home. Megan declined medical attention and was advised the incident would be on record. A copy of this report was left for the animal control Officer.
