Meeting was opened at 6:30 PM. Present were Selectboard members Rich Kuklewicz, Chris Boutwell, and Matt Lord; Town Administrator Steve Ellis; Executive Assistant Wendy Bogusz; DPW Superintendent Tom Bergeron; Assistant Town Administrator Hiring Committee Chair Greg Garrison; Town Planner Walter Ramsey; and FCRHRA Director of Community Development Brian McHugh.

Selectboard Chair opens the meeting, including announcing that the meeting is being recorded, and roll call taken.

Bergeron shares that Warner Brothers, who is doing our paving this year, is going to try a new product on a test section of Turners Falls Road. The product will consist of recycled plastic.

## Joseph Barry, Tyler Finnegan, Amias Callender, Derrick Prather, Republic Services Check in regarding trash collection problems

- Resident Melissa Sibley thanks Republic for their services. However, she is concerned about trash not being picked up as there is a fox and a groundhog in the neighborhood that gets into the trash.
- Lord states that the eastern portion of Center Street has had some problems with trash pick-up. He asks Amias if he has a quantifiable understanding of how much of the Town is not getting regular pick-ups. Amias responds that he does.
- Amias reports that last week one of his trucks wasn't running on Monday. One of the Tuesday-and-Wednesday trucks failed inspection. They have gotten two brand new trucks that have been field-tested. They have created a hot list for the drivers to understand which areas need special attention.
- Finnegan explains that there is a 9-12 month wait for getting new trucks.
- Kuklewicz asks Republic to put a supervisor out to help patrol a route; he states that the residents are getting so
  angry that they are posting on social media and threatening to bring their trash to Town Hall or the Selectboard's
  yards.
- Airport Director Bryan Camden states that trash has been falling out of the back of the trucks and would like the drivers to be more mindful. His workers are constantly having to go out to the street and pick up the trash.
- Bergeron states that several residents have reported that when they call Republic, they wait for long periods of time and then get hung up on. He says the DPW gets upwards of 30 calls a day, which takes a big chunk out of their day.
- Ellis states that Town Hall is getting hundreds of calls over the course of a month, which interferes in the productivity of the staff. He commends Amias's professionalism but agrees with Kuklewicz that there should be an accompanying driver. He strongly emphasizes that this cannot continue and that doing this right should be routine at this point after four months in.
