Eversource Petition for Solely and Wire Locations Hearing Install (2) fully owned poles on Billings Road and Relocate (2) existing poles on N. Leverett Road

- David Short, property owner on Billings Road, shares that the Eversource Arborist says Eversource wants to take out a number of trees. The property owners are in agreement.
- Boutwell makes the motion to approve the request from Eversource to install (2) fully owned poles on Billings Road and Relocate (2) existing poles on N. Leverett Road. Seconded by Lord, unanimously approved. Boutwell Aye, Lord Aye, Kuklewicz Aye

 - o In response to a question by Pick, Ellis recommends that the committee, once appointed, can appoint a Chair who can be delegated specific activities including liaisoning.
 - o Kuklewicz encourages folks who are interested in being the committee to let Bogusz know.
 - O Pick says that she has four people "firmed up" to be in the committee.
 - o In response to a question by Pick, Kuklewicz states that the committee can have more than five.

ARPA Spending Plan

Summary of Present Commitments (Steve)

Ellis reviews the Summary of Present Commitments, pointing out that two additional expenses should have been deducted from our total funds remaining (\$20,000 for lights and \$10,000 for signage related to the winter parking program). This would leave a little over \$1 million available for spending.

Discuss Capital Project Requests and Vetting Process

- o Ramsey lists the project requests by different departments:
- o The Libraries would like a feasibility study for a new library.
- The DPW and the Airport would like guard rail improvements and roadway improvements along Industrial Boulevard.
- o The DPW would like to replace the Town Hall Parking Lot.
- o The Town Accountant would like storage at the Town Hall Annex.
- The Town Clerk would like fire and water-proof records storage cabinets.
- o The Parks and Recreation Director would like improvements to the Montague Center Park (part of a match).
- Ramsey states that we have enough ARPA funds for all of these projects, but it would not leave us with much extra.
- o Ramsey suggests we run these proposals through the Capital Improvements Committee.
- o Ellis states that not all of the projects need to be funded with ARPA funds.
- o Boutwell and Lord agree that the Capital Improvements is the committee to go to for recommendations.
- o Pick suggested adding solar installation at the DPW Building onto the list.
- O Boutwell makes the motion to forward the proposals for discussion to Capital Improvements. Seconded by Lord, unanimously approved. Boutwell Aye, Lord Aye, Kuklewicz Aye

Walter Ramsey, Assistant Town Administrator

Farren Property Updates

- o Trinity Health reaffirmed that their intention is to demolish the hospital and gift up to 10 acres to the Town.
- o Trinity will reimburse the Town up to \$100,000 in expenses toward the Site Redevelopment Study.
- They have hired a contractor and a project manager and have submitted their demolition permits to the Town Building Department.
- This will begin in November and is a 10- to 12-month process, a significant amount of which will be in asbestos abatement.
- Because of a new bylaw, the Historical Commission has to schedule a public hearing, which they have 45 days to do.
- Opportunities were identified for preservation of ancillary structures.
- The Historical Commission provided a list of things they want to see preserved on the site.
- o Kuklewicz suggests saving a few pallets full of brick.

Comprehensive Plan Status Update

- We received funding from the Municipal Vulnerabilities Program to complete the Comprehensive Plan.
- We are on track to complete the second phase by June 30, 2024.
- o The scope of work totals \$80,000.
- o This phase (Phase II) involves developing the seven or so chapters that go into a master plan.
- We will be doing some community engagement sessions with the public this winter.

Montague City Road Flooding Relief Project Update

- We had a bid opening on Thursday and are in the process of vetting the bids.
- We should be able to offer the contract with a fairly strong contingency of \$65,000 (20% of construction costs).
- We are working on permitting with the Army Corps of Engineers and DEP.
