- Testimony Provided Regarding Permanent Remote and Hybrid Meeting Legislation Ellis shares his testimony regarding Permanent Remote and Hybrid Meeting Legislation during a meeting with a group of legislators who are considering sponsoring legislation related to the open meeting law and remote meetings:
 - The Town feels the current decision to continue remote meeting accommodations in their current form was excellent.
 - We hope the delay period will be used to engage municipalities such as Montague with the legislators as they move forward with their thinking in the design of their bills.
 - Communities cannot be subjected to another unfunded mandate.
