He states that there are Town members who have found ways to advocate for issues that they find important and they have made their voices known. Lord states that from his perspective, he is doing the best that he can to build a process that engages with the appropriate sets of people in Town who are knowledgeable and experienced in making these types of decisions.
- o The Board agrees to move forward with the plan.

Town Administrator Report (Presented by ATA Walter Ramsey)

• Discussion of Potential Municipal Vulnerabilities Program (MVP) Grant Request to Support NPDES Compliance, to Require 25% Match

Ramsey states that the NPDES draft permit requires major stormwater event plans for the collection system and treatment plan. We have asked Wright Pierce to develop a quote and hope to submit it to the MVP grant program. The Board endorses this plan.

• FirstLight FERC Settlement Updates

We have a tentative agreement on final Recreational Settlement language that protects the Town's right to comment on matters related to erosion during the upcoming REA (fed term)/401 water quality review (statement) process. We would expect the revised copy to be available for the next meeting. FERC has signaled that they will accept our Recreation Settlement agreement even after the May 1 deadline.

- Endorse Steve Ellis' Appointment to Mass Economic Development Planning Council

In response to a question by Kuklewicz regarding the Montague City Road project, Ramsey states that Davenport is talking about mobilizing in late June or July. Ramsey adds that he has been working with our engineering firm to get through the final hurdles of the State and Federal permitting agencies that we are working with.
