- The Retirement Board feels that this increase is necessary to protect the standard of living for retirees and their well-being, and also that this will benefit the Town by securing a benefit that will aid in both staff recruitment and staff retention.

Low Income Household Water Assistance Program (LIHWAP)

- Peter Wingate, the head of the program, had told Seymour that some taxpayers had reached out to them.
- The taxpayers pay for sewer and water bills that are in arrears.
- There is a requirement criteria; not everyone is eligible.

• Boutwell makes the motion to authorize the Treasurer/Collector to sign the contract with Community Action of Pioneer Valley and the Town of Montague for the Low Income Household Water Assistance Program. Seconded by Lord, unanimously approved. Boutwell - Aye, Lord- Aye, Kuklewicz - Aye

Gill Montague Regional School District

- Update on status of application to MA School Building Authority (MSBA)
 - o Beck discusses the intention to build a new elementary school to replace Hillcrest Elementary School. This project would involve building an expansion onto the existing Sheffield Elementary School.
 - The Statement of Interest has not been formally accepted by the MA School Building Authority (MSBA), but has not been rejected at this point in time.
 - o The MSBA will conduct a senior study, which would involve meeting for several hours with Beck, the Principal, Blier, the Director of Facilities, and representatives from the Town.
 - According to the feedback from the meeting, anywhere from 25% to 50% of the school districts that had senior studies will be approved depending on the overall amount.
 - O Blier states that we are meeting with the MSBA next month, and that the invitation period into the MSBA Program could be within the next six months.
 - o If we are accepted, we would form a Building Committee and would need to request funds from the Town to do a feasibility study and design. Blier believes these funds would be 76% to 85% reimbursable.
- Request for Affirmation of Selectboard Support of MSBA Application

Boutwell makes the motion to affirm the request from the Gill-Montague School District to continue the MSBA Application. Seconded by Lord, unanimously approved. Boutwell - Aye, Lord- Aye, Kuklewicz - Aye

Town Administrator Business

- Discuss schedule for September Meetings, schedule for finalizing Town Meeting Warrant and Recommendations
 - o The Special Town Meeting Warrant needs to be set by September 25.
 - The Selectboard meeting on September 11 will be via ZOOM. The Selectboard will review the Town Meeting Warrant during this meeting.
 - The meeting on September 18 will be in-person. The Selectboard will have the goal of approving the Town Meeting Warrant during this meeting.
- Request that Chris Boutwell be named a Special Municipal Employee (not on agenda)

- Notice of Federal FY22-23 CDBG Grant Award of \$1,325,682
 - Ellis shares that he attended an event in Gardner in which he was informed that Montague has received a Federal FY22-23 CDBG Grant Award of \$1,325,682. Ellis also shares that he spoke with the new Chair of the Executive Office of Housing and Livable Communities and broached the idea of creating a Micro Entitlement Program for communities such as Montague. The Board approves Ellis's sending a letter to follow-up on that question.
- Request authorization to contract for services up to \$10,174.88 to secure the Strathmore Mill Complex from unauthorized entry. Funds to be drawn from the Community Development Discretionary Unsafe/Unhealthy Buildings Account

- Update on Farren Care Center Demolition Schedule and Process for Acceptance of Land
 - The project is on track for a November completion.
 - The building demolition is not quite done.
 - o Pulverizing of material on-site for processing and movement will continue into September.
 - The backfill, top soil, and seeding will take place in October.
 - O Underground storage tanks have been removed.
 - There is an item on the Special Town Meeting Warrant that would give the Selectboard authorization to accept the property.
