- There now is a village-to-village organization. It already has a bank account, a website, and volunteers. Its mission statement is "helps adults over 60 residing in the Town of Montague to age in place with dignity and dependence by offering volunteer services, access to information, and community connections."

Montague City Road Flooding - Relief project updates

- The conditions are still too wet to continue the work.
- We have commenced the contracting process with Davenport. The contract will hopefully be brought to the Board in the next two weeks.
- The DPW is going to clean the culvert at Turnpike Road in the hopes that that will help free up the stream to move the water along.

Montague Center Library Masonry and Roof Repair updates

- The masons mobilized last Tuesday and hope to be done by the project by the end of this week.
- The building has been pressure-washed. Some bricks have been replaced. Gravel work is being done.
- We are planning to mobilize the roofers in two or three weeks.
- A new leak was found in the roof. Ramsey has asked the roofers to take a look at it.
- The window in the attic is also in really bad shape. A local window restorer is willing to restore it for \$1,100.

First Street Housing Development update

- The First Street Housing Development project is moving along well.
- We are still not scheduled for ultimately a January land transfer.
- Habitat for Humanity will be hosting a community meeting to talk about the project on Saturday, September 30.
- The design is well-underway.
- The Phase II Environmental Assessment work has been completed. We are waiting on the results.
- One of the issues at the community meeting will be how to address the cars that are parking in the alleyway.
- The alleyway is in rough shape. The DPW will be looking into it.

• The building on 38 Avenue A is now demolished.
