Discussion of pending UEW MOA

Truck Driver/Laborer in Training

The change in the CDL training requirements in the Commonwealth of Massachusetts have affected Bergeron's ability to hire people into the entry level Truck Driver/Laborer position. Seeking to develop a credentialing program would be challenging for our community. Creating a Truck Driver/Laborer in Training position beginning in Grade B would allow Bergeron the time to assess an individual.

Lead Heavy Equipment Operator

The position of Lead Heavy Equipment Operator would be modified in that the individual would take on extra responsibility when they are actively preparing for and managing an in-the-field job site, which would provide clarity and supervision at the job site. This would provide them out-of-grade pay and in the process negate the Town's obligation to have an individual filling that role at all times.

Custodian Services

We have had a vacancy for a Custodian for a while, but we are not generating candidates. In the short term, we are looking to an outside vendor as an option, but we would need to include an out clause in the contract.

o Uniform Allowance

Bergeron's Mechanic Team would like the same accommodation given to the staff of the Clean Water Facility, which involves shifting to a uniform service that would focus the bulk of their stipend on steel-toed boots.
