#### **Sewer Commission Meeting**

#### **CWF Superintendent Chelsey Little**

#### Tax share discussion on special article request for Millers Falls/Erving overage of \$94,667.83

- Little and Olsen have been discussing the best way to address the overage charge in the budget.
- o Little has a Special Article for FY25 Annual Town Meeting when we would get the bill from Erving.
- Little has to do an I/I calculation; the Town's tax base pays for some I/I that the Enterprise Fund has to pay for and treat.
- o It might make the most sense to have the overage difference put into the Enterprise Fund operating budget.
- o In response to a question by Lord, Olsen states that there is no intra-town contract between the CWF and the rest of the Town as to how to determine the calculation of how much the taxpayers pay towards the treatment plant's budget.
- o The Board decides that putting the overage difference in the operating budget is the way to go.

#### **Summary of January Discharge Permit Report**

- o Everything is in the green.
- Our new NPDES Permit went into effect on January 1, 2024. We are limited to 153 lbs/day of nitrogen. We were at 91.6 for the month, but typically we are at 5.

#### **Summary of January Blending Events**

- We have a wet weather chlorine contact tank, which helps to divert some of the high flows that come into the plant. It settles out any solids, floatables, trash debris, etc. so that we can disinfect some of the pathogens.
- On January 10 we discharged about 94,000 gallons.
- o In response to a question by Lord, Little explains that our NPDES permit requires a 24-hour reporting of the event to them. Then we have to do a report of discharge within five days, then a monthly report of discharge, then an annual report of all the discharges that occur throughout the previous calendar year.

#### DPW Superintendent Tom Bergeron Summary of January CSO Events

There was one overflow reporting on Avenue A during the month of January.

#### **Update on DPW NetDMR registration**

Bergeron states that they need to do a NetDMR report on the 15th stating what is happening with our lines and send it to the DEP and the EPA.

#### Action Plan for I/I Source Investigation in Millers Falls

- o Kyle Bessette found that the main pipe is still flowing badly. The second one has died down.
- O They tried to get a smoke machine from a colleague, but were told it is not available until April 1st. Bergeron is looking into purchasing one.
- O Green Mountain has a lateral camera that can do the service, but they don't know what the cost would be until they get here. Bergeron is looking at the smoke machine first.
- Bergeron has contacted the State for permission to dig in the road or the side of the road. They have not responded.
- Bergeron states that the goal is to find the source. Wherever it is, the property owner will have to deal with it.
- Little states that it is illegal to attach any drainage into a line. She wonders if the source is at 12 Federal, which
  is owned by the bank, and if it would make sense to send the bank a letter. Bergeron states it is not coming
  from that house.

Kuklewicz asks Bergeron to work hard on his equipment list and give the Board really good, honest assessments of the grades of the equipment. This would make it less surprising when there is a need for a replacement.

- In response to a question by Singleton, Bogusz states that Thomas's current license is a restaurant license. They are not a restaurant, so the type was changed to General On Premise.
