- o Boutwell states that prefers using the Town Hall Annex.
- o Lord would like to know how this workspace fits in with the overall improvement plan for the CWF. What is the timeline?
- o Kuklewicz would like the Town Hall Annex to be ultimately used for Town Hall use but is willing to explore the costs for using it temporarily for the CWF.
