Avenue A CSO Reduction/Buffer line project updates/alternative proposal to re-line sewer manholes

- Ramsey states that Wright Pierce did a detailed investigation and found that the buffer line is performing largely as it was designed to. They conclude that a large wholesale change is not necessary, but do recommend that we install an orifice plate which would regulate the amount of water that goes into the buffer line. The cost would be approximately \$24,000. This project can be done in-house.
- Ramsey suggests using the remaining grant funds to address all of the Turners Falls priority one manhole relining projects and make a mark on Millers Falls priority one manhole relining projects (up to 51 manholes all together). Wright Pierce has put together a proposal for their engineering services.
