## CWF Capital Project Updates: Industrial Blvd. Pump Station, Ops Boiler/Underground Storage Tank, Septage Receiving Station

- The Industrial Boulevard Pump Station project is complete. We used the Rural and Small Town Development Grant (\$169,000) and spent approximately \$15,000 out of the CWF Operating Budget. Little reviews how the new pump station works.
- Regarding the Ops Boiler/Underground Storage Tank, Little states that they have stabilized the boiler and have ordered some Modine heaters to replace the faulty ones. She states they are also dealing with the underground fuel tank storage in the operations building.
- Little summarizes the way the Septage Receiving Station works. Site work is almost finished. The tank is expected to be delivered in November.

### Permit Discharge Summary for July 2024

Everything went well except for the chlorine. Little believes this was due to a mechanical pump issue, which has been addressed.
