#### **Assistant Town Administrator's Business**

### Close out two projects (not on agenda)

Nolan-Zeller states that through an accounting reconciliation, we were able to identify that based on projects that have been closed up already, we have about \$6,000 that hadn't been accounted for. He requests that the Board close out two projects in order to free up some leftover funds.

### Turners Falls Manhole Repair and Relining Project Status and Bidding Plan

- o This project will be put out to bid in mid-November for a bid opening date of December 10.
- This is Phase I of the project which is being funded by a \$500.000 grant from the Rural Small Town Development Fund.
- Phase II is going to be a later phase that consists of all the remaining Priority 1 and 2 work in both Turners and Millers Falls. That is being put through the Capital Planning process.

### **Carnegie Library Basement Project Status**

- GCS has finished demolishing the interior walls in the basement site and have identified several areas of substandard framing.
- Nolan-Zeller displays two alternates proposed by GCS.
- The Library Building Committee, the Library Director, the Building Commissioner, and the contractor prefer Alternate 1, which is what is needed to bring the building up to code. The grand total for this is \$12,280.

- Alternate 2 will cost approximately the same.
- o In response to a question by resident Betty Tegel, Kelley states that the main floor of the Carnegie Library is serviced by an ERV. The current project will include installing an HRV.
- O Boutwell makes the motion to authorize the use of \$5,280 in ARPA funds to effectuate Change Order No. 1. Seconded by Lord, unanimously approved. Boutwell Aye, Lord Aye, Kuklewicz Aye

### **Town Hall Parking Lot Project**

- o Both of the buildings are down and the foundations have been removed and filled.
- The DPW is planning on rolling on the fill so that it is no longer a hazard, which will hold us over until the spring.
- o The exposed window has been boarded up. We will need a long-term plan with regard to the window.
- o Tegel pointed out that the handicapped spaces need to be more legible.
- Tegel also asks that the entrances to the back of the Town Hall and to the annex be checked and made safe for handicapped individuals.

## Other projects updates

- Capital requests are due this week.
- We are working on an expression of interest for the FY26 MVP Action Grant round. We are aiming to complete a study of stormwater drainage on the hill section of town.

#### First Street Housing Development - Status Update

- The project slowed down when an environmental assessment found fill on the site that contains some hazardous material. A supplemental round of testing was done, and we are now working through the Franklin Regional Brownfields Program to determine a mediation strategy.
- Habitat for Humanity had been awarded a grant from the Neighborhood Stabilization Program to help fund the construction. Due to the slow-down, the grant has been withdrawn. Habitat for Humanity is encouraged to reapply after the soil situation has been addressed.
- Our partners are Mass Development are aware of what is going on. All the State agencies that can help are willing to.

#### Fifth Street Bridge Weight Limit Posting

- o The Fifth Street Bridge is open again to two-way traffic.
- The hope is that the intervention will allow the bridge to remain open until the next inspection cycle next September.
- o There will be a weight limit posted on the bridge (17 tons for a two-axle truck).
- o The bridge is slated for replacement in 2027-2028.
- Kuklewicz asks Ramsey to send a letter of thanks to the District 2 folks for responding so quickly.
