Guiding Considerations for Re-opening

Montague is restoring Town buildings, programs and services to as close to full operation as possible

It is being done in a manner that:

- Greatly reduces the risk of COVID-19 transmission/infection
- Respects State and Montague Board of Health orders
- Is responsive to evolving public health guidance
- Recognizes that all programs cannot be on the same schedule
- Shows respect for our employees and the public



Foundational Safety Standards

Re-Opening of Town Buildings will reflect mandatory safety standards established by the State of MA

This includes protocols in four domains

- Social Distancing
- Hygiene Protocols
- Cleaning and Disinfecting
- Staffing and Operations

Re-Opening Town Hall: Critical Things to Know

- Town Hall is open to the public starting Thursday, June 25th
- Public hours are from 10:30-12:30 and 3:30-5:30 daily
- There is a limit of 1 visitor per department at a time
- Appointments are <u>strongly</u> recommended. Call ahead!
- Walk-ins accommodated wherever possible
- We cannot accept cash payments, please plan accordingly
- Front vestibule is still open for quick mail/document drop-off
- We still encourage use of phone, email for routine matters

Town Hall Public Entry Requirements

Public Safety Requires Certain Conditions be met before Entry

- We have instituted a <u>one-way</u> walking traffic flow
 - Visitors must enter through lower (back) parking lot doors
 - Exit through Avenue A front vestibule, except in instances of limited mobility
- Visitors must wear a proper face covering no exceptions
- Visitors must answer screening questions and comply with a temperature check to determine entry is allowable
- Visitors must use town-provided hand sanitizer as they enter

Note: a limited quantity of masks may be available for public use



Re-Opening of Other Town Facilities

Other Town offices will also re-open on June 25th or are providing curbside or outreach service. Call ahead for schedule and details.

- Montague Police, WPCF, and Airport offices, as well as the Parks and Recreation Department's Unity Park Fieldhouse open June 25
- Montague DPW: Outside drop off and meetings available
- Libraries: Curbside pick-up and delivery only until further notice
- Senior Center (COA): Outreach service only until further notice
- Additional Notes
 - Montague playgrounds are open
 - Parks and Recreation Day Camps will not be open this summer

- Please continue to conduct your business through remote means wherever possible
